TREATMENT ACCOUNTABILITY FOR SAFER COMMUNITIES

TASC—the linking of the treatment community with the corrections system—began in the early 1970s, funded through federal sources. When the federal funding ended the model evolved and in 1988 the Colorado Department of Corrections began funding the Denver TASC program. Today the program is Colorado TASC—a statewide system that is accessed by parolees in all regions of the state, focused on substance abuse and co-occurring disorders.

TASC is a proven model developed to connect parolees with substance abuse treatment and other needed services. At the heart of our success is comprehensive, client-centered case management supporting the parolee's transitions from prison to community through a continuum of care.

SAFER COMMUNITIES.

Colorado TASC enhances public safety while holding offenders accountable during their transition into the community. We accomplish this by emphasizing responsibility, recovery, and community engagement, by actively monitoring treatment program participation as well as supporting recovery maintenance.

Principles such as innovation and partnership guide our work and enable us to build and sustain programs that are cost-effective, proven solutions with meaningful opportunities for the parolee—while enhancing the safety of our communities.
